## The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

### Notification by a Member of Disclosable Pecuniary and Non-Pecuniary Interests

#### PART A - PECUNIARY INTERESTS

**NB** - In accordance with Section 34 of the Localism Act 2011, a person commits an offence if, without reasonable excuse, they fail to register their pecuniary interests within 28 days of taking office or fail to update their register within 28 days of a change to their pecuniary interests.

\* Body in which any of the above named persons has a beneficial interest means a firm in which any of the above named persons is a partner or a body corporate of which any of the above named persons is a director, or in the securities of which any of the above named persons has a beneficial interest.
